

**PROCEEDINGS OF UNION COUNTY QUORUM COURT
MAY 21, 2015**

MINUTES

The regular monthly meeting of the Union County Quorum Court was held on May 21, 2015 in the Union County Courthouse. Judge Mike Loftin called the meeting to order and led the Court in the Pledge of Allegiance. Justice Dumas led the Court in an opening prayer. The Clerk called the roll from the following list:

Justice William Crowder was absent but with ten justices present the following business was transacted.

The Justices were previously mailed a copy of the minutes of the April 2015 Quorum Court meeting. A motion for adoption was made by Justice Vestal and seconded by Justice Chandler. Motion carried.

The Justices were also mailed a copy of the Budget Comparison and a copy of the Recap of Revenues for the month of April 2015. A motion for adoption of the Budget Comparison and Recap of Revenues was made by Justice Chandler and seconded by Justice Burson. Motion carried.

An Appropriation Ordinance sponsored by Justice Dumas and to be entitled "AN ORDINANCE TO APPROPRIATE A PORTION OF FELONY DRUG FINES IN ORDER TO FUND THE UNION COUNTY ADULT DRUG COURT AND THE UNION COUNTY SHERIFF'S DEPARTMENT DRUG OPERATIONS (BUDGET LINE ITEM NUMBER 1000-0400-3104) AND TO PROVIDE FOR PAYMENTS OF SUCH FINES FROM DRUG RELATED CONVICTIONS IN UNION COUNTY, DECLARING AN EMERGENCY AND OTHER PURPOSES" was read by the clerk. After a brief discussion a motion for adoption was made by Justice Polk and seconded by Justice Platt. The clerk called the roll and the following Justices answered in the affirmative: Burson, Chandler, Dumas, Foster, Hendrix, Jones, Platt, Polk, Storey and Vestal. Those answering in the negative: None. Those abstaining: None. Ordinance No. 1342 was approved as read.

An Ordinance sponsored by Justice Dumas and to be entitled "AN ORDINANCE TO CREATE A NEW FUND, DEPARTMENT AND LINE ITEMS, APPROPRIATE FUNDS AND AMEND THE FY2015 BUDGET." The FY2015 Budget is hereby amended to include the addition of a new budget, department and line items, which will be known as the Drug Court Program Fund- Budget 3028-Department 0433. There is hereby appropriated the sum of \$.04 from Union County General Funds as follows: Line 2001 – General Supplies \$.01, Line 3030-Travel \$.01, Line 3100-Other Misc. \$.01 and Line 3101-Training & Education \$.01, was read by the clerk. After a brief discussion a motion for adoption was made by Justice Vestal and seconded by Justice Burson. The clerk called the roll and the following Justices answered in the affirmative: Burson, Chandler, Dumas, Foster, Hendrix, Jones, Platt, Polk, Storey and Vestal. Those answering in the negative: None. Those abstaining: None. Ordinance No. 1343 was approved as read.

An Ordinance sponsored by Justice Dumas and to be entitled "AN ORDINANCE APPROPRIATING FUNDS." An ordinance to appropriate the sum of \$4,200.00 from unappropriated Union County General Funds to Budget 1000 – Dept. 0500 (Emergency Services) –

Line 3107 (LLEBG Grant) was read by the clerk. After a brief discussion a motion for adoption was made by Justice Burson and seconded by Justice Jones. The clerk called the roll and the following Justices answered in the affirmative: Burson, Chandler, Crowder, Dumas, Foster, Hendrix, Jones, Platt, Storey and Vestal. Those answering in the negative: None. Those abstaining: None. Ordinance No. 1344 was approved as read.

An Ordinance sponsored by Justice Dumas and to be entitled "AN ORDINANCE TO CREATE A NEW POSITION, APPROPRIATE FUNDS AND AMEND THE FY2015 BUDGET." There is hereby created a computer tech position within the Union County Sheriff's Department, Fund 1000 – Dept. 0400 and there is hereby appropriated the sum of \$31,950.00 from unappropriated County General Funds for this position as follows: – Line 1001 (Salaries Full Time) - \$19,110.00, Line 1006 (SS Match) - \$1,463.00, Line 1008 (N/C Retirement) \$2,796.00, Line 1009 (Health Ins. Match) - \$8,581.00 was read by the clerk. After a brief discussion a motion for adoption was made by Justice Jones and seconded by Justice Storey. The clerk called the roll and the following Justices answered in the affirmative: Burson, Chandler, Crowder, Dumas, Foster, Hendrix, Jones, Platt, Polk, Storey and Vestal. Those answering in the negative: None. Those abstaining: None. Ordinance No. 1345 was approved as read

With no other business a motion to adjourn was made by Justice Storey and seconded by Justice Chandler. The meeting was adjourned.
